## SECTION 4 : FIRST AID MEASURES

Use personal protective equipment that is clean and has been properly maintained.

## SECTION 11 : TOXICOLOGICAL INFORMATION

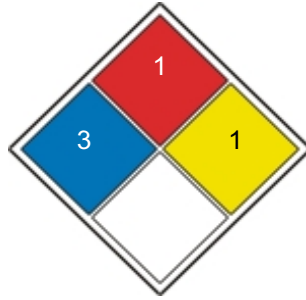
