- Ensure adequate ventilation, if possible with extractor fans at work posts and appropriate general extraction.
- Personnel shall wear regularly laundered overalls.

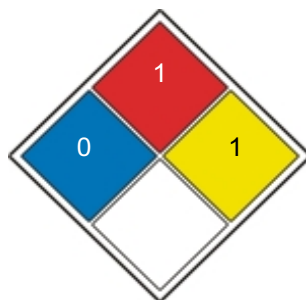
